To transfer both teaching locations and course, you are required to complete this application form. No additional forms are required.
- 2. You **MUST** read and understand the 'Enrolled Students Changing Program' process on International Admissions Procedure before completing this form which is located <u>here</u>.
- 3. Course transfers are only available between courses at the same level, eg, from a bachelor's degree to another bachelor's degree.
- 4. You MUST have a valid Visa for study and appropriate Health Cover.
- 5. You should have NO outstanding fees owing to Federation University.
- 6. Some courses have essential requirements that must be satisfied before you will be considered for a place (eg interview, audition etc). Review the entry requirements via <u>Course Finder</u> and include any evidence to demonstrate how you meet the 'essential requirements' with this form.
